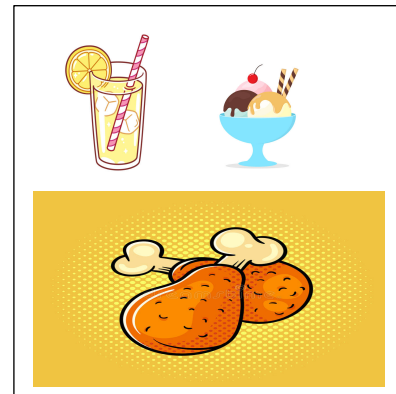

As your Membership Chair, please let me know if you have changes in your address, phone numbers, email address, etc. so that I can keep the chapter's roster up to date.

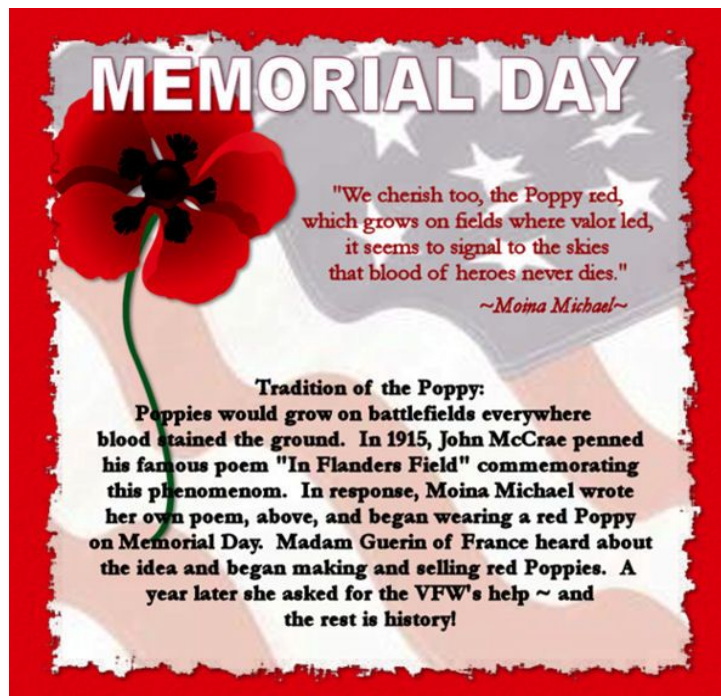

Legislative Affairs Update

MOAA Member to Lead Panel on Quality of Life

MOAA President and CEO Lt. Gen. Brian T. Kelly, USAF (Ret), and MOAA Government Relations staff members met with Rep. Don Bacon (R-Neb.) in January to share MOAA's priorities for the 118th Congress and discuss a newly announced panel on military quality-of-life issues. Bacon, a retired Air Force brigadier general and MOAA member, will lead the bipartisan panel expected to be stood up this year. Military pay, housing, health care, child care, spouse employment, and food insecurity are likely to be on the panel's agenda when hearings begin in late spring or summer. During the meeting, Kelly emphasized the importance of ensuring the ongoing viability of the all-volunteer force. He pledged MOAA's support for the panel and appreciation for the committee's renewed focus on military quality-of-life issues—topics that align closely with MOAA's legislative priorities. A [Military.com](https://www.military.com) article noted the congressional panel's efforts will likely extend beyond this year, with recommendations potentially included in the FY2025 National Defense Authorization Act, the defense authorization bill Congress will consider in 2024. The article quoted Bacon on the bipartisan nature of the effort: "I know there's folks on both sides of the aisle really desiring to be part of this because this has a chance to impact our military for decades to come," he said. "I think people are also yearning for a bipartisan focus. This is not a Republican or Democrat focus. It's going to be a patriotic national focus of serving the folks who defend our country." MOAA looks forward to working with Bacon and his staff and all members of the congressional panel to address quality-of-life issues for servicemembers and their families and to ensure our nation fulfills its commitments to the uniformed services community.

COL (ret) Ebersole served as a U.S. Army Nurse Corp officer in the Reserve Component and active Army for 25 years. Carol served as Chief Nurse in the Arizona National Guard, Staff Officer in the National Guard Bureau, Chief Nurse for the 309th Medical Group. During Desert Storm, she was assigned to Fort Belvoir, VA as head nurse in Critical Care and Recovery Room, and then as Assistant Chief of Professional Services. A year later, LTC Ebersole was promoted to Colonel in the U. S. Army Reserves and served in the 100th Station Hospital with active-duty tours in the internal medicine clinic at Walter Reed Medical Center. Summers were spent as nurse practitioner for West Point in the field hospitals medically serving the troops in training. COL Ebersole retired in 1999.



MOAA National Surviving Spouse Corner

The 2023 Advocacy in Action in person DC visits took place the third week of April. The state contingent that called on Arizona legislators consisted of the immediate AZ council past president, state legislative affairs liaison and a surviving spouse liaison. It is exciting to have Nora Dunham, a recent addition to the national Surviving Spouse Advisory Board representing our interests.

Look for more information on the congressional visits in the next newsletter.

Please support the Caring for Survivors Act of 2023. S414/H.R.1083. This legislation would increase the DIC payment to surviving spouses from 43% of the 100% disability pay to 55%. That increase would put the amount in line with other federal employee programs.

As with any proposed bill with financial ramifications, there will be an uphill and probably long battle to receive the benefits deserved. Much like the repeal of the "Widows Tax", it will take time and a lot of grassroots work from our members. Please contact your lawmakers and ask for their support and co-sponsorship.

There have recently been 20 new burn pit and other toxic exposure presumptive conditions added to the initial list, based on the PACT ACT.

This change expands benefits for Gulf War and post 9/11 Veterans and their survivors. If you or your spouse were previously denied or have not yet applied for benefits call 800-698-2411 or go to <https://www.va.gov/resources/the-pact-act-and-your-va-benefit>

If you need help filling out forms for benefits, your local VFW and DAV have VA trained volunteers who can help.

There have been a number of instances recently when DFAS has fallen short of expectations in processing pay and benefits. I have had three surviving spouses contact me looking for

information and where to go for help. This problem was recently brought up at a Surviving Spouse Virtual Meeting. The MOAA Director for Government Relations, Mark Belinsky is asking for those who have an issue, to report it to MOAA. The number and type of issues will help forge a solution or policy adjustment.

I will be speaking at the AZ COC bi-annual meeting in Phoenix. I will be providing an update on surviving spouse issues. Following this meeting, I will be sending my PowerPoint presentation to all of the chapter liaisons to distribute to their members. If you would like a copy, please send me an email.

JUNE LUNCHEON
GUEST SPEAKER:
COL (RET) THOMAS KIRK, USAF

Tom Kirk was born in 1928 in Richmond, Virginia, and grew up in Portsmouth, Virginia. He was commissioned in the U.S. Air Force through the Air Force ROTC program at Virginia Military Institute on June 13, 1950, and he completed Undergraduate Pilot Training and was awarded his pilot wings on June 30, 1951. Kirk flew B-29 Superfortress bombers in Georgia and Kansas before serving in combat during the Korean War flying the AT-6 Texan as an Artillery Spotter and then the F-86 Sabre between November 1952 and November 1953. After Korea, Kirk flew with fighter squadrons in Louisiana, Belgium, and Italy, before going through Air Command and Staff College at Maxwell AFB, Alabama from September 1960 to July 1961. His next assignment was at Edwards AFB, California from July 1961 to September 1963. He then served an Air Force Institute of Technology assignment at the University of Southern California, where he earned an MBA. Kirk served at Myrtle Beach AFB, South Carolina, with the 354th Tactical Fighter Wing, from September 1964 until he left for an overseas assignment in Japan in November 1965. He served as Operations Officer of the 356th Tactical Fighter Squadron at Misawa AB, Japan, until July 1967, when he began flying combat missions as the Commander of the 357th Tactical Fighter Squadron out of Takhli Royal Thai AFB, Thailand. On October 28, 1967, Col Kirk was forced to eject from his F-105 Thunderchief when it was hit by anti-aircraft fire over North Vietnam. He was immediately captured and taken as a Prisoner of War. After spending the next 1,964 days in captivity, he was released during Operation Homecoming on March 14, 1973. After hospitalization, Col Kirk became the Deputy Commander for Operations and then the Wing Commander of the 29th Flying Training Wing at Craig AFB, Alabama. He next served as Deputy Commander of the Lowry Technical Training Center at Lowry AFB, Colorado, and finally as Vice Commander of all Special Forces in Europe before retiring from the Air Force on March 31, 1978. After his retirement, Tom lived in Italy and Spain before settling in Colorado in 1992. He is married to the former Ann Berardi of Canton, Massachusetts, and they have two sons; Thomas H. Kirk III and Robert T. Kirk.

His Air Force Cross Citation reads:

Lieutenant Colonel Thomas H. Kirk, Jr., distinguished himself by extraordinary heroism in connection with military operations against an opposing armed force as an F-105 pilot near Hanoi, North Vietnam, on 28 October 1967. On that date, Colonel Kirk planned and led a 24-aircraft strike force against an important and heavily defended railroad and highway bridge near Hanoi. Despite seven surface-to-air missiles being fired at him and extremely poor visibility, Colonel Kirk, with undaunted determination, indomitable courage, and professional skill led his force to a precise ordnance delivery point, placing his own bombs directly on the target. His aircraft sustained a direct hit from the extremely intense antiaircraft fire. He courageously flew his burning aircraft until it became completely uncontrollable and he was forced to eject over hostile territory. Through his extraordinary heroism, superb airmanship, and aggressiveness in the face of the enemy, Colonel Kirk reflected the highest credit upon himself and the United States Air Force.

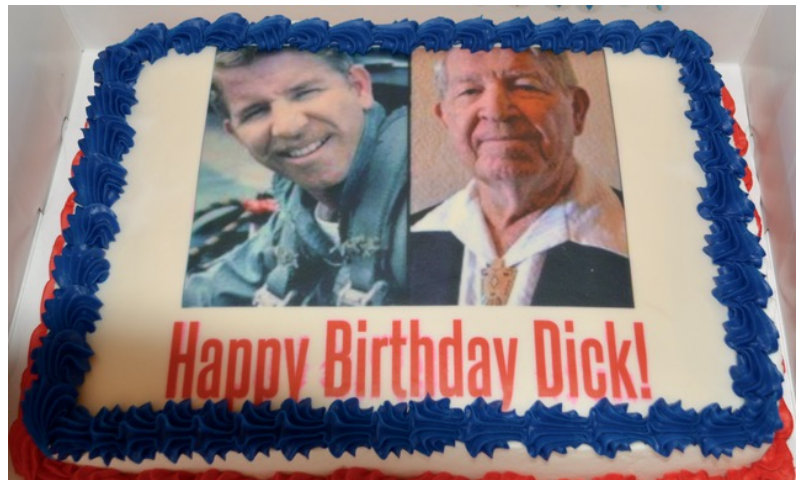
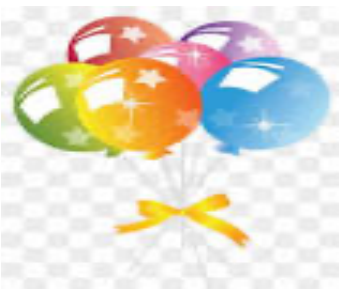

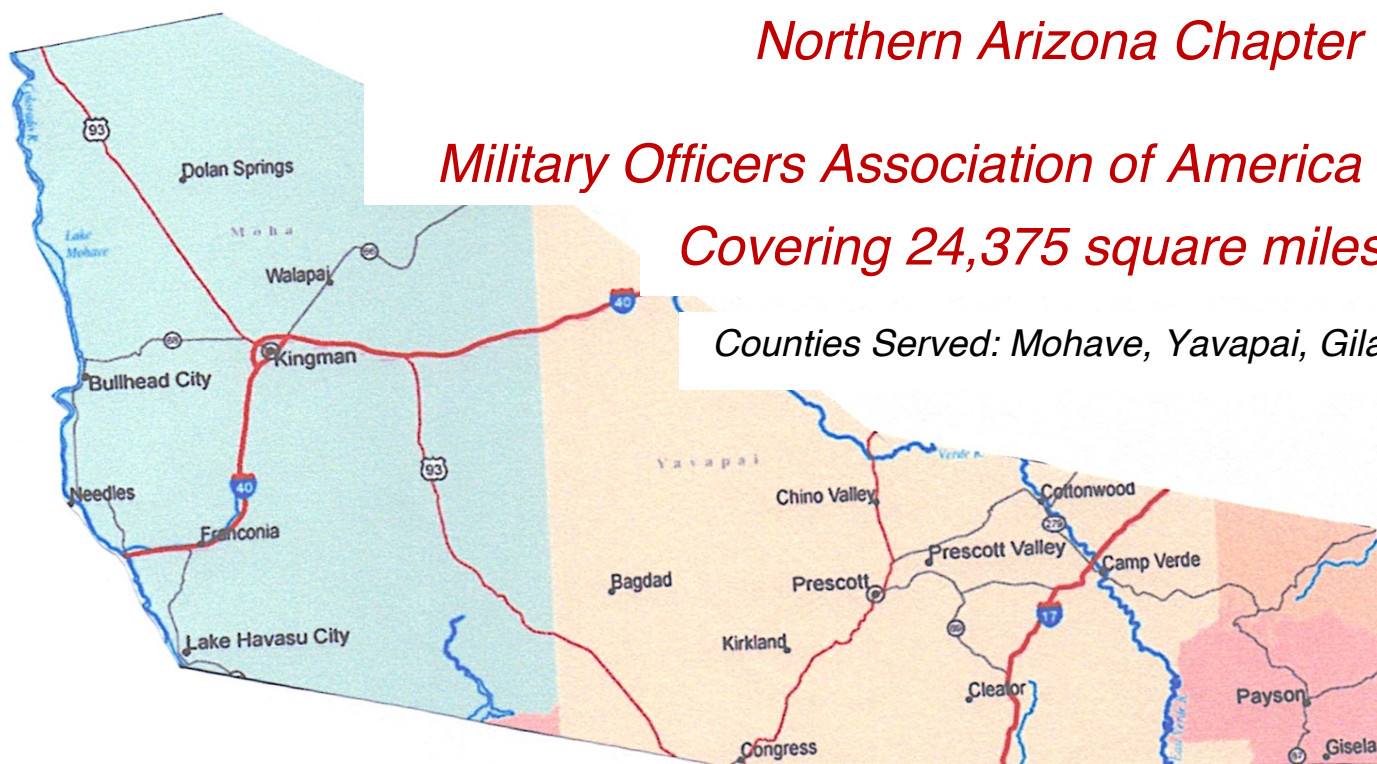
