**JUNE GUEST SPEAKER - BRYAN CAMPBELL
EXECUTIVE DIRECTOR, U.S. VETS**

Bryan Campbell, the new Executive Director of U. S. VETS Prescott is a Retired United States Marine Corps Veteran spanning a 20-year career with multiple tours of duty in Afghanistan, Iraq, and the Marine Expeditionary Unit.

In 1997 Bryan joined the Marine Corps from a small town in Arkansas. After basic training he began his pipeline of training towards his military occupational specialty as a UH-1 helicopter crew chief. In 2009, the Marine Corps presented Bryan with the prestigious Danny L. Radish award as the enlisted "Aircrewman of the Year" and in 2010, he was Combat Meritoriously promoted to the rank of Gunnery Sergeant. Bryan also served as a Drill Instructor (DI), preparing those young recruits with the solemn duty of Honor, Courage, and Commitment. Bryan received numerous awards during his meritorious service to our country to include the Air Medal with combat "V" and 22 strike flight numerals. First Sergeant Campbell retired in 2018 and sent his wife Trisha out to find a place to move to.

Prescott became the obvious choice. In 2022, Bryan joined U.S. VETS as a Program Manager and in typical Marine Corps fashion, as an integral part of a 39-member professional team expanded housing services in a way that seemed inconceivable years earlier. In 2023, he was recognized and presented with the "Outstanding Site Leadership Award". Not having any thought of climbing the executive ladder, he still felt "he had a sense that this was where I need to be". "I want to cultivate a culture-one team, one fight, we're all here to chip in for the greater good; and I'm not afraid to roll up my sleeves."

When Carole Benedict the Executive Director of U.S. VETS was appointed to National Director of Executive Leadership, she hand-picked Bryan as her successor. Bryan Campbell in December was appointed as the new Executive Director of U. S. VETS - Prescott. As he stepped into the roll, he brings "the best of everything". As he carries the mantel forward into a future of innovation and growth, Bryan's leadership and deep commitment to the core values, will be instrumental in U.S. VETS' success.

LEGISLATIVE AFFAIRS UPDATE

Each spring, MOAA Council and Chapters, with support from the National HQs, bring specific, high priority legislative action to every member of Congress. This year MOAA's Advocacy in Action (AiA) campaign took place in Washington, DC, on 17 April 2024. The Arizona contingent was led by Colonel Pete Kloeber, USAF (Ret). The priorities for this year are passing the Richard Star Act (H.R. 1282/S. 344), restoring full BAH (H.R. 2537/S. 1823) and protecting TRICARE for Life.

Protecting TRICARE for Life has no required legislation; however, in recent years the Congressional Budget Office (CBO) has made recommendations for cost reductions by suggesting increases for beneficiaries to include enrollment fees and increased co-pays. MOAA's goal is to remind Congress to keep their promise made to all TRICARE beneficiaries that TRICARE for Life is an earned benefit.

The Richard Star Act continues to receive opposition from members who are concerned about the costs associated with the passage of the act. MOAA believes that cost should not be a factor when it comes to military members who have been injured in the line of duty while serving this great nation.

I'm asking you to immediately go to the Legislative Action Center and send letters to our Senators and Representatives using the links in the center. You may want to personalize the opening paragraph with an explanation of your service and that you are an active voter.

-TRICARE Pharmacy Change

Effective 01 March, 2024 you can now fill your speciality drugs through TRICARE Home Delivery. You will start to receive expanded specialty pharmacy services from Accredo Health Group, Inc.

-H.R. 7777 and S. 4047, the Veterans' Compensation Cost-of-Living Adjustment (COLA) Act of 2024. This bill would increase VA compensation benefit rates for veterans and those in receipt of Dependents Indemnity Compensation (DIC).

Without annual COLAs, many disabled veterans, who sacrificed their own health and family life for the good of our nation, may not be able to maintain the quality of life they deserve. We must ensure that veterans' benefits keep pace for the many veterans and survivors who are on fixed incomes and largely rely on their compensation payments for basic necessities.

Please contact your Senators and Representative and urge them to co-sponsor and support the Veterans' Compensation COLA Act of 2024. Thank you for supporting a cost-of-living increase for our nation's service- disabled veterans, their families and survivors.

-Urge your lawmakers to protect TRICARE for LIFE

Nearly a decade has passed since the Department of Defense (DoD) proposed – and MOAA defeated – TRICARE for Life (TFL) enrollment fees in five consecutive administration budget requests from FY2013 to FY2017. The recently released FY2025 DoD budget request makes no mention of new TFL fees – so why are MOAA advocates taking this issue to Capitol Hill?

TFL is a top priority issue for MOAA members. Aside from military retired pay, it is the most valued part of the military retirement package. It not only ensures access to affordable preventive and routine medical care, but it protects uniformed services retirees and their dependents and survivors from financial risk associated with unexpected costs for serious and unexpected illness or injury.

Although there are currently no active proposals for TFL fee increases, credible threats to the benefit loom on the horizon. The Congressional Budget Office (CBO) has consistently included TFL fees in its Options for Reducing the Deficit report released at the beginning of each new Congress.

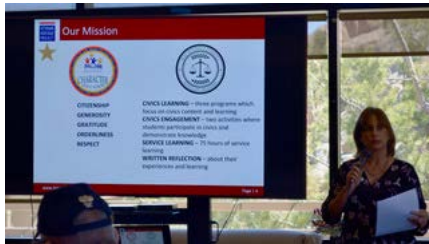
