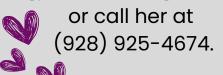

#### **Surviving Spouse Update**

TFL no longer covering GLP 1 medications for weight loss MOAA Military Officer's Magazine Sept. 2025

Weight-loss drugs such as Wegovy, Zepbound, and other GLP-1 medications are no longer covered for TRICARE For Life (TFL) beneficiaries as of Aug. 31, though the other TRICARE plans continue to offer coverage, with prior authorization.

TRICARE policy has never approved coverage for GLP-1 drugs simply to lose weight or for cosmetic purposes. The prior authorization process requires documentation of comorbid medical conditions that can be improved or eliminated by taking GLP-1 medications.

Those prescribed GLP-1 drugs for Type 2 diabetes (Trulicity, Ozempic, Mounjaro, or Victoza) will be able to continue their treatment plans.

MOAA pushed for the Defense Health Agency (DHA) to delay the planned Aug. 31 coverage change, citing two key concerns:

- The move threatens the significant strides made by many GLP-1 users in reducing or eliminating weight-related ailments such as sleep apnea or high blood pressure while improving their quality of life.
- The change sets a dangerous precedent by creating two classes of drug coverage for TRICARE and TRICARE For Life beneficiaries. Future moves could widen this coverage difference, significantly weakening the TFL benefit.

MOAA's work on the issue, which has received national media attention, will continue on multiple fronts, as we engage DoD health officials and lawmakers. Much of that work involves research into TRICARE's legislative and regulatory history, as a means to better understand the DHA's claim that TFL coverage of weight-loss medication is "inconsistent with existing statutory and regulatory authority."

While the patchwork of statute and regulations involving TRICARE coverage of weight-loss treatments is complex, MOAA has not discovered any federal statute specifically excluding TFL beneficiaries from coverage of GLP-1 drugs or other treatments. There are, however, multiple instances of federal statute requiring a uniform pharmacy program benefit across all TRICARE categories -- instances which appear to run counter to the recent GLP-1 ruling. As we present these arguments to lawmakers and DoD officials alike, we will advocate for updated federal regulations to preserve the TFL benefit and continue coverage parity for GLP-1 drugs and in future coverage decisions.

Ensuring world-class coverage for all TRICARE beneficiaries, regardless of age, remains at the heart of MOAA's mission.

## **LEGISLATION UPDATE:**

#### H.R. 2055 - 119th Congress (2025-2027)

- The Caring for Survivors Act of 2025 was re-introduced. It would increase Dependency
  and Indemnity Compensation (DIC) paid by the Veteran's Administration to surviving
  spouses from the current 43% for those who qualify for the 100% disability compensation
  to 55% which will equal other survivor programs. If you are a disabled veteran, this bill
  could financially help your spouse.
- Action: June 24, On Hold in the House Subcommittee on Disability Assistance and Memorial Affairs Hearings continue. August: Congressional recess.

#### H.R.2148 Veteran Caregiver Reeducation, Reemployment, And Retirement Act.

- This legislation acknowledges caregivers' invaluable contributions while addressing the significant economic and emotional burdens they face. By offering education, employment, and retirement opportunities, the legislation empowers caregivers to achieve financial security while potentially reducing the federal government's long-term economic burden.
- This legislation would improve caregiving support for veterans' families. This includes enhancements to the VA Program of Comprehensive Assistance for Family Caregivers (PCAFC) and expansion of home health and long-term care services to meet current and future needs of veterans, their caregivers, and families.
- It includes Reimbursement of fees associated with certifications or licensure renewal necessary for such employment.
- Access to training modules for the purpose of gaining credit for continuing professional education requirements, access to training modules of the Department at no cost.
- Action: Carried over to September to Congress' agenda.

#### H.R. 3509 Supporting our Surviving Spouses Act

• A bipartisan House bill that would remove a statute of limitations on claiming some survivor benefits for post 9/11 servicemembers. Currently the time limitation is six years.

# IN MEMORIUM – NAC MOAA RECOGNIZES & CELEBRATES THE LIVES OF RECENTLY DECEASED MEMBERS

#### NAC member Ivan Burnett's wife Joanne passed

November 10, 1935 - July 9, 2025

Joanne Munsil Burnett passed away peacefully on July 9th, 2025, at the age of 89. A dedicated nurse, teacher, author, and loving wife, mother, and grandmother, Joanne led a life of service, compassion, and unwavering commitment to her faith, family, and profession.

Born in Phoenix, Arizona, Joanne was the third of seven children and a proud second-generation Arizonan. She attended Emerson Elementary School and graduated from North Phoenix High School, where she lettered in five sports and served as president of the Girls' Athletic Association.

Though Joanne was quiet by nature and never sought the spotlight, her brilliance was unmistakable. She taught herself to read well before first grade, and her intellect was evident in her ability to calmly manage the most difficult patients, solve advanced logic puzzles, and write articles so erudite they were later cited in medical textbooks.

Joanne earned her nursing diploma from Good Samaritan Hospital School of Nursing in 1957, where she was elected class president and received the Florence Nightingale Award for outstanding leadership and academic excellence, followed by a B.S. in Nursing from Arizona State University and two M.S.N. degrees from the University of California, San Francisco.

Over the course of her career, Joanne worked as a nurse and educator across the U.S. and abroad—including in Arizona, California, New Hampshire, Guam, Virginia, and Florida—often following her husband's Navy chaplain assignments. She held teaching positions at Arizona State University, Old Dominion University, and the University of Guam. Her pioneering work in pediatric and developmental nursing was published in the American Journal of Nursing.

Joanne was also the author of several books, including Piaget's Babies, Take Charge! of Your Baby's Development, The Professional and the Hospitalized Child, and Granny Smith's Sudoku Solver. She was known for her sharp intellect, quiet strength, and deep empathy for others.

Despite the challenges of Parkinson's Dementia in her final years, Joanne remained loving, witty, and engaged with those around her. She will be remembered for her deep devotion to family—including her 57-year marriage to her beloved husband Ivan—her nurturing spirit, and her ability to bring people together—from Grand Canyon rafting trips to family reunions and church activities.

Joanne was preceded in death by her son David Burnett, her parents Lee and Evelyn Munsil, Sr., and 4 of her siblings: Marilyn Stout, Bil Munsil, Lois Hunt, and Martha May Patterson. She is survived by her husband Capt. Ivan Burnett, Jr., CHC, USN; her son Daniel Burnett; her grandchildren Christopher Burnett, Jordan Burnett, Craig Burnett, and Fiona Burnett; and her two remaining siblings Lee Munsil, Jr., and Wesley Munsil. A memorial service will be held at a later date.

Virginia Ruth Brehm, "Gini," was born in Chicago on November 8, 1937 to Rose and Archie Brehm. Her family lived on Coles Ave.in Chicago. Gini attended Loretto Academy, a Catholic girl's school.

She married Daniel Schappert and with him had four children: Laura, David, Susan and Derek. After divorcing her husband she worked for Intrupa, a forklift parts supplier, in Grayslake, Ill. She met Ray Jordan in Libertyville, Illinois in 1994, and in 2000 they moved to Apache County, Arizona to a house in Concho. In 2004 Gini and Ray moved to Baderville, near Flagstaff, to a house they purchased.

On June 15th, 2015, Gini and Ray were married.

{I'm told Gini was tired of all the snow near Flagstaff, so,} In May 2020 they moved to a house in Paulden, Arizona where they lived to the present.

Gini suffered from dementia and died at Rutledge Ranch in Paulden on July 27.

Her funeral WAS in Flagstaff August 18 at San Francisco de Assis Catholic Church, with burial following at Calvary Cemetery in Flagstaff.

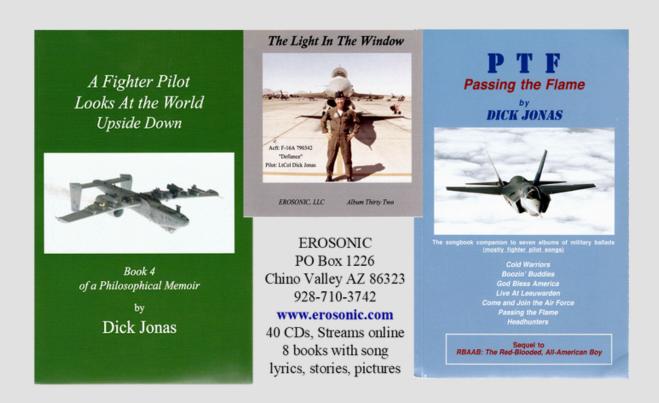
