## LEGISLATIVE AFFAIRS UPDATE

### **MOAA's Summer Advocacy in Action (AiA) Campaign**



#### **Major Richard Star Act (S. 1032 / H.R. 2102)**

Combat-injured veterans deserve their full earned compensation, and this legislation reinforces our promise to support those who served — long after they've left active duty. The Star Act is an enduring priority for MOAA, and we are excited to report it has generated significant momentum since last spring. The benefits offered by the Major Richard Star Act are not new. Congress eliminated the retirement pay/disability pay offset more than two decades ago, yet lawmakers left out those forced to retire due to combat injuries. This bill simply ends this unfair exclusion.

This legislation would fix a long-standing injustice that affects combat-injured veterans who were medically retired before reaching 20 years of service. Right now, many of these veterans lose a portion of their earned retirement pay because of an outdated offset. The Star Act would allow them to receive both their full military retired pay and VA disability compensation—as they should.

The bill has strong bipartisan support, currently 372 Representatives and 27 Senators, but it will only move forward if members of Congress hear directly from constituents like us **ASAP**. - Cosponsor and actively support the Major Richard Star Act (S. 1032 / H.R. 2102);
- Push for a floor vote or inclusion of the Star Act amendment in the National Defense Authorization Act this session. It's quick, easy, and extremely effective

#### **Arizona Legislative Action**

The Arizona Legislature returned to Phoenix in early January, and with it comes another important opportunity to support policies that strengthen the lives of our veterans, currently serving members, and their families.

The Arizona Council of Chapters will continue to work closely with the House Veterans Caucus, the Arizona Department of Veterans' Services, and the DoD State Liaison Office to develop a slate of veteran-centered bills for the upcoming session. Once that agenda is finalized, they will once again call upon us—MOAA's grassroots advocates—to help move these priorities forward. Council and Chapter Activity on the Legislative Action Center (LAC) I strongly urge members of the chapter to register in the MOA LAC even if you don't immediately want to submit an action. Our chapter's registration rate is tracked by MOAA headquarters but much more importantly, if you later want to submit an action in the future, it will be simple to do so because you will already be registered.

## Surviving Spouse Update January 2026

Happy New Year. I hope you all had a happy holiday season.

Congress will be back in session soon, marking a new year to enlist co-sponsors and support for bills that are so important to our surviving spouses and veterans.

Mrs. Linda Wolverton, serves as the Arizona State Surviving Spouse Liaison and Luke Chapter Surviving Spouse Liaison. She has done a great job of compiling information regarding the bills that were presented to Congress last year, but needs our help to become new laws.

### H.R.2055 - 119th Congress (2025-2026) The Caring for Survivors Act of 2025

It would increase Dependency and Indemnity Compensation paid by VA to surviving spouses from 43% of 100% disability compensation to 55%. The bill reduces, from 10 years to 5 years of total disability, in order for a survivor to qualify for benefits; and specifies the amount that is payable to survivors of veterans who were rated totally disabled for a period of less than 10 years before their death

### H.R. 2278, Survivor Benefits Delivery Improvement Act March 21, 2025:

The Survivor Benefits Delivery Improvement Act, would increase the monthly rate for dependency and indemnity compensation (DIC) for the surviving spouses and dependents of military members and veterans who died as the result of their service-related illnesses and injuries.

Note: This includes enhancements to the VA Program of Comprehensive Assistance for Family Caregivers (PCAFC), expansion of home health and long-term care services to meet current and future needs of veterans, their caregivers, and families; Access to employment assistance under the Military OneSource program of the Department of Defense and Reimbursement of fees associated with certifications or licensure renewal necessary for such employment.

### H.R.2148 Veteran Caregiver Reeducation, Reemployment, And Retirement Act.

This legislation acknowledges caregivers' invaluable contributions while addressing the significant economic and emotional burdens they face, by offering education, employment, and retirement opportunities.

### S.1027 AND H.R. 2033 - Military Spouse Hiring Act (identical bills)

Is a bill aimed at incentivizing employers to hire military spouses by expanding the Work Opportunity Tax Credit (WOTC) program.

Pact Act Surviving Spouse Information updated with additional diagnoses

Male breast cancer and urethral cancer, additional blood cancers, and new conditions like hypertension and [Monoclonal Gammopathy of Undetermined Significance \(MGUS\)](#), for Agent Orange exposure. Other additions include more presumptive conditions related to burn pits, like various respiratory, gastrointestinal, and head cancers. Surviving spouses may now submit claims for DIC if their spouses had any of the conditions on the expanded list. Go on [www.va.gov](http://www.va.gov) for other presumptive conditions from Agent Orange and other exposures.

Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 and were exposed to toxic substances will be eligible to enroll in VA health care starting March 5.

Veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the U.S. will also be eligible to enroll. Veterans eligible for VA health care under these authorities do not have to apply for VA benefits before enrolling.

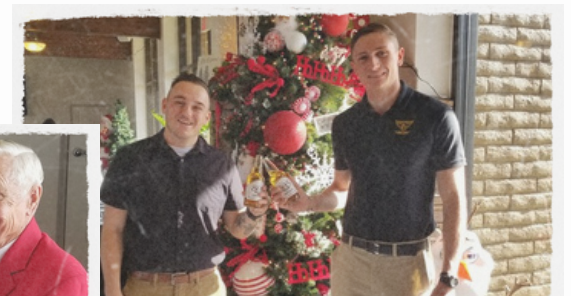
